


 Food facilities cannot distribute single-use articles that are neither compostable nor recyclable



- Retail establishments cannot sell **expanded polystyrene products**
- Flexibility for certain food applications w/o options for compliant products



 Third-party online food ordering businesses must allow food facilities to indicate which single-use foodware accessories they offer for customer selection



 Full-service restaurants must provide multiservice utensils instead of single-use articles to dine-in customers
